The Central Community School District Board of Education met for the regular school board meeting on August 13, 2014, at the Central Middle School Media Center at 6:00 p.m. Directors Jim Irwin, Christy Kunz, Angela Rheingans, Steve Fuglsang and Jennifer Naeve were present along with Superintendent Peterson and Secretary Bartels. Administrator present was: Kurt Kreiter. Media representatives Nick Joos, The Observer, and Jan Huffman, Clinton Herald were also present.

President Kunz opened the meeting at 6:01 p.m. The Pledge of Allegiance was recited.

The public hearing regarding proposed Athletic Facilities Enhancement Project was opened. No comments were made. Moved by Director Fuglsang, Director Irwin to close the public hearing. Motion carried 5-0.

Moved by Director Irwin, Director Rheingans to approve the tentative agenda as presented. Motion carried 5-0.

Moved by Director Fuglsang, Director Irwin to approve the minutes of July 9<sup>th</sup>. Motion carried 5-0.
